Article No. (2) DEFINITIONS

2.1 Domain Name Registration Application Form of .ae: means the form published by the Registry for the purposes of soliciting information from persons or entities seeking to register an Internet domain name

2.2 UAEnic: is part of Emirates Telecommunications Corp. - Etisalat & and Registry of .ae

Article No. (3) No liability for UAEnic

3.1 Both parties agree that UAEnic shall have no liability to them for any losses or damages, including any kind of loss or damage whether in contract, tort (including negligence) or otherwise.

In connection with the this Transfer Agreement and /or Registration Agreement of .ae

Article No. (4) Accuracy of Information &Contact details

4.1 Both parties agree to provide UAEnic with all the Contact details in order, certain current, complete, accurate, and reliable contact data at the time of transferring the Domain Name registration as required by the transfer and /or registration process such as Tele, Fax and /or e-mail and /or otherwise

4.2 Transferee agrees to update this Data including but not limited to the following: (a) If Transferee Contact Data changes after he/she supplies same to UAEnic, but before UAEnic transfers a domain name to his/her name; and (b) If Transferee Contact Data changes after UAEnic transfers a domain name to his/her name, Transferee agrees to update the data with the UAEnic within 30 days from the date the data has been changed.

Article No. (5) Breach

5.1 It will be considered a material breach of this Agreement and Registration Agreement of .ae if Transferee : (a) Willfully provides inaccurate or out of order Contact Data, (b) Willfully fails to promptly update Contact Data with the UAEnic, (c) Fails to respond within (15) fifteen days to UAEnic inquiries or those of the UAEnic concerning the accuracy of the Contact Data. Such a breach will be a significant basis for UAEnic to cancel the domain name registration and/or other services without further notice to Transferee.

5.2 If within (15) fifteen calendar days of the date of such notice, Transferee fails to provide evidence that is reasonably satisfactory to UAEnic that Transferee has not breached his/her obligations under this Agreement and Registration Agreement of .ae, then the Registry may delete Transferee 's registration of the Domain Name without any refund entitlements and/or fees for the Registrant and without prejudice to any other remedies to which the Registry may be entitled. Any such breach by a Registrant shall not be deemed to be excused simply because the Registry did not act earlier in response to that, or any other, breach by any party of this agreement

Article No. (6) General Conditions

6.1 Transferee acknowledges and agrees that he /she must provide UAEnic and/or .ae registrar(s) with the completed registration application form of .ae duly signed and should provide any document, which may be relevant, along with this agreement to enable him/her to transfer the domain name under his/her name.

6.2 Transferee also, agrees that UAEnic may suspend, cancel or transfer his/her domain name services in order to: (i) correct mistakes made by the registry in registering his/her chosen domain name, or (ii) to resolve a dispute under the Dispute Policy of .ae

6.3 Transferee also agrees that UAEnic shall have the right in its sole discretion to suspend, cancel, transfer or otherwise modify his/her domain name registration under .ae at such time as UAEnic receives (i) a properly authenticated notification from UAE court (ii) an arbitration award requiring the suspef his/her domain name registration.

6.4 Transferor shall not transfer any domain name to any party if the domain name was TOSed (Temporary out of service) and /or cancelled or otherwise.

6.5 UAEnic will not refund any fees paid by Transferee or Transferor.

6.6 UAEnic does not endorse or recommend any person, organization, name, product or service or Links to Other Websites referred to in the UAEnic website.

7. Language.

7.1 All communications between Registry and Transferee in relation to the registration and transfer of a domain name shall be in Arabic or English as requested by Registry.

8. Fees.

8.1 The Transferee agrees to pay the Registration and transfer Fees and, when applicable, the Renewal Fee.

Article No. (9) APPLICABLE LAW

9.1 This Agreement shall be governed by and construed according to the Law(s) of UAE.
